Articles to be condemned can be physically examined on sites on "As is where is" basis at the earmarked space of basement of New Building (except some heavy articles installed in the respective Departments, & to be auctioned on in-situ basis) **between 10:00 AM to 12:30 PM from June 21 to 25, 2010 (Between 10.00 AM to 12.00 Noon)** under the supervision of Store Keeper, Medical Equipment Store (Tel. 011-23404565) of the Hospital.

The Medical Superintendent, Dr R M L Hospital, New Delhi invites Tender bids, subject to the TERMS AND CONDITIONS noted below: -

1. The sealed tenders, complete in all respect, signed with stamp/seal of the firm, addressed to **MEDICAL SUPERINTENDENT** should be dropped in the tender box placed near the Reception Counter, Old (Heritage) Building, Dr RML Hospital, New Delhi on or before **29<sup>th</sup> June, 2010, (Tuesday) by 10:30 AM.**
2. Tender bids should be neatly typed written, free from erasers, overwriting and cuttings. Otherwise, it will be summarily rejected without assigning any reasons.
3. Tender Bids will be opened in the presence of tenderers present himself/herself or in presence of authorized representative (with proper authorization letter).
4. Delayed and late tenders i.e. the tenders received after the due date and time will not be accepted.
5. Incomplete/Conditional tenders will not be accepted.
6. In case of an unscheduled Holiday on the prescribed tender opening date, the tender will be opened on the next working day.
7. No correspondence will be entertained after opening of the tender from the tenderers.
8. **Security Deposit (Refundable) of Rs. 50,000-00** (Rupees Fifty thousand only) strictly in the shape of DEMAND DRAFT/ PAY ORDER in favour of "PAO, Dr Ram Manohar Lohia Hospital, New Delhi", should be attached with

the tender failing which the tender will be treated as invalid and cancelled without any further reference /reasons.

9. In case of Tender Form in downloaded from Website, please also attached separately with a tender application fee of Rs.1000/- (Rupees one thousand only) in the in favour of "PAO, Dr Ram Manohar Lohia Hospital , New Delhi".

10. Successful bidder will have to deposit the entire highest bid amount in the Cash Counter(Window No 23,Old Building) of Dr R M L Hospital New Delhi, within 02 days from the date of opening/ awarding the Tender.

11. The 25 % of amount quoted will have to be deposited immediately in Cash in the Accounts Section at window No 23-A, old (Heritage) building of the hospital and produce original receipt to the In-charge Storekeeper, Medical Equipment StoreDepartment. The balance 75% amount shall be deposited within 2 days from the date of opening/ awarding the Tender, failing which, the 25 % amount deposited shall stand forfeited.This will exclude the Earnest/Security Money of Rs.50,000/-.

12. Tenderer's full address & contact No. must be written on the backside of DEMAND DRAFT/PAY ORDER of security deposit.

13. If the highest bidder fails to deposit the whole amount within stipulated time, order will be given to the second highest bidder at the price quoted by the First Bidder and in that case, security deposit of the highest bidder will stand forfeited.

14. Security deposit will be refundable to unsuccessful bidders at the earliest possible time after the date of opening/awarding of tender bids.

15. Security Deposit of the successful bidder will be refunded after the auction site is cleared and handed over in neat & clean condition to the Store Keeper, Medical Equipments Store.

16. The auctioned articles including the in situ large & heavy items to be dismantled in the respective Departments, should be removed **at their own expenses** within **four** working days from the date of opening/awarding of tender or making payment, failing which penalty @ **Rs. 5000/- per day** will be charged extra.

17. Medical Superintendent/ The Auction Committee reserve the right to accept or reject any bid, at any stage, without assigning any reasons what-so-ever.

18. If the number of tenders received is not sufficient, the date of opening may be extended by the Auction Committee.

19. The employees of the Hospital and their relatives are not eligible to take part in the tender process.

20. All legal disputes will be settled within the jurisdiction of DELHI.
