

- 3. Qualification & Experience: Retired physiotherapist or Sr. Physiotherapist from Central Govt. Organizations having minimum 5 years of experience.
- 4. Age Limit: Maximum 64 years as on last date of application.
- 5. **Period of Engagement:** Initially for one year or till attaining the age of 65 years whichever is earlier.
- 6. **Remuneration:** The remuneration and other terms and conditions for retired Government Servants against posts of Consultant (Legal) will be as per Department of Expenditure OM Mo. 3-25/2020-E.IIIA dated 09.12.2020. No increment, DA and HRA shall be admissible.

Annexure-I

Eligibility for the post of **Consultant (Legal)** in Dr. Ram Manohar Lohia Hospital, New Delhi purely on contract basis:-

- 1. Name of the post: Consultant (Legal)
- 2. No. of Posts: 02 (Two)
- 3. Qualification & Experience: Having Law degree with one year experience in the field.
- 4. Age Limit: Maximum 64 years as on last date of application.
- 5. **Period of Engagement:** Initially for one year or till attaining the age of 65 years whichever is earlier.
- 6. **Remuneration:** The remuneration and other terms and conditions for retired Government Servants against posts of Consultant (Legal) will be as per Department of Expenditure OM Mo. 3-25/2020-E.IIIA dated 09.12.2020. No increment, DA and HRA shall be admissible.

(1) TERMS & CONDITIONS

- 1. The appointment is purely on contract basis for a period of one year initially and extendable periodically on yearly basis as decided by the competent authority subject to satisfactory work & conduct but not beyond the age of 65 years. or till regular incumbent joins, whichever is earlier.
- 2. The Authority reserves the right to terminate the appointee by giving a seven day notice or paying remuneration for 7 days in lieu of notice, any time during the tenure even without assigning any reason or for failure to perform assigned duties to the satisfaction of the competent authority.
- 3. The remuneration will be as per prescribed vide. DOEOM No: 3- 25/2020-E.IIIA, Ministry of Finance, Dept. of Expenditure dated 9th. Dec 2020. The remuneration will commence from the date of reporting to duty at the place of posting.
- 4. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion, Leave encashment etc. or any other benefits available to the officers appointed on regular basis. No other allowances or monetary benefits in any form shall be admissible.
- 5. The appointee shall perform the duties assigned to him/her by the competent authority. It reserves the right to assign any duties as and when required. No extra/additional allowance will be admissible in case of such assignment.
- 6. The appointee shall be entitled paid leave of absence @ 1.5 days for every completed month which is liable to be lapsed, if accumulated, at the end of calendar year. Accumulation of leave beyond a calendar year may not be allowed.
- 7. This is a full time appointment; hence the appointee shall not accept any other appointment paid or otherwise.
- 8. Any declaration given or information furnished by the appointee if found to be false or information is found to be suppressed then the appointee shall be liable for termination from contractual appointment without prejudice to such other action by the Government as deemed necessary.
- 9. The contractual appointment and continuation thereof, if any shall be governed exclusively by the terms and conditions stated herein above.
- 10. Appointee has to be medically fit before joining and has to submit a certificate in this regard.

(2) CRITERIA FOR SELECTION

Sr. No. 1) From amongst the retired physiotherapists or senior physiotherapists from central govt. organizations having minimum of 5 years of experience.

Sr. No. 2) From amongst the retired Government Employees (Level 8) Having Law degree with one year experience in the field.

(3) SALARY STRUCTURE

Salary will be as per the terms and conditions for regulating contractual retired employees as prescribed vide. DOEOM No: 3- 25/2020-E.IIIA, Ministry of Finance, Dept. of Expenditure dated 9th. Dec 2020.

A fixed monthly amount shall be admissible, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the term of the contract. There will be no annual increment / percentage increase during the contract period.

(4) ALLOWANCES

HRA (House Rent Allowance)

No HRA shall be admissible.

Transport Allowance

An appropriate and fixed amount as Transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement. The amount so fixed shall remain unchanged during the term of appointment. However, retired employees engaged as consultants may be allowed TA/DA on official tour, if any, as per their entitlement at the time of retirement. Vide. DOEOM No: 3- 25/2020-E.IIIA, Ministry of Finance, Dept. of Expenditure dated 9th. Dec 2020.

(5) TIMING / DUTY HOURS

- Sr. No. 1) Timing will be from 9.00 AM to 4.00 PM, Monday to Friday and from 9.00 AM to 1.00 PM on Saturday.
- Sr. No. 2) Timing will be from 9.30 AM to 4.30 PM, Monday to Friday and from 9.30 AM to 1.30 PM on Saturday.

(6) LEAVE RULES

1. The appointee shall be entitled paid leave of absence @ 1.5 days for every completed month which is liable to be lapsed, if accumulated, at the end of calendar year. Accumulation of leave beyond a calendar year may not be allowed.

(7) SELECTION BOARD

Selection criteria will be based upon the scrutiny of the application and walk in interview by a Committee constituted by Medical Superintendent.
